- E1 - 0'-0" (H) TO 0'-10" (H) (VARIES) PARAPET WALL. REMOVE EXISTING EDGE METAL AND WALL FLASHINGS. INSTALL FULLY ADHERED WALL FLASHING UP OVER EXIST. TOP PLATE AND DOWN FRONT FACE. INSTALL NEW TWO PIECE METAL FASCIA (SEE DET. 0001)
  - E2 - GRAVEL STOP EDGE METAL, REMOVE EXISTING EDGE METAL, INSTALL NEW WOOD BLOCKING TO MATCH HEIGHT OF NEW ROOF SYSTEM & NEW GRAVEL STOP EDGE METAL W/ FULLY ADHERED FLASHING (SEE DET 0002)
