- EDGE CONDITIONS LEGEND:**
- E1** - GRAVEL STOP EDGE METAL, REMOVE EXISTING EDGE METAL, INSTALL NEW WOOD BLOCKING TO MATCH HEIGHT OF NEW ROOF SYSTEM & NEW GRAVEL STOP EDGE METAL W/ FULLY ADHERED FLASHING (SEE DET. 0001)
 - E2** - 9" (H) TO 7'-6" (H)(VARIES) X 0'-10" TO 1'-0"(W) PARAPET WALL. REMOVE EXISTING METAL COPING, ALL WALL FLASHINGS AND ANY LOW METAL COUNTER FLASHING. INSTALL 1/2" DENS DECK MECHANICALLY ATTACHED TO FLASHING SUBSTRATES WHERE BUR FLASHINGS HAVE BEEN REMOVED. INSTALL FULLY ADHERED WALL FLASHING UP OVER EXIST. TOP PLATE AND DOWN FRONT FACE, INSTALL NEW TWO PIECE METAL FASCIA (SEE DET. 0002)
 - E3** - 7'-6" (H) SLOPED FLASHING TO 9'-0" (H) VERT. WALL FLASHING X 0'-10" TO 1'-0"(W) PARAPET WALL. REMOVE EXISTING METAL COPING, ALL WALL FLASHINGS AND ANY LOW METAL COUNTER FLASHING. INSTALL 1/2" DENS DECK MECHANICALLY ATTACHED TO FLASHING SUBSTRATES WHERE BUR FLASHINGS HAVE BEEN REMOVED AND OVER SLOPED FLASHING AREA. INSTALL FULLY ADHERED WALL FLASHING UP OVER EXIST. TOP PLATE AND DOWN FRONT FACE, INSTALL NEW TWO PIECE METAL FASCIA (SEE DET. 0002)
